### NEWS

- The Panel established under art. 14 of the EPPO Regulation has already sent to the Council the ranking for 5 Countries (CY, GR, LT, AT and IT) over 8 in order to cover the positions of the 8 outgoing European Prosecutors
- The preparatory bodies of the Council have already agreed on a list of the 5 new European prosecutors to be appointed which, in 4 over 5 cases, reflects the ranking of the Panel.
- The Coreper should adopt a partial decision already next week and the Council should ratify it during one of its next meetings as an A) point.
- The Panel will resume next week in order to finalize the selection procedure in order to send to the Council the ranking concerning the remaining candidates for the 3 remaining positions (SP, P and NL).
- The overall procedure should be concluded by the early July in order to avoid any vacuum for the functioning of the EPPO after the summer break.

# 4. LAWYERS SUBCOMMITTEE

### CRIMINAL LAWYER: FABRIZIO DE' SANNA

- For this meeting, we are required to come prepared with a brief presentation on a topic related to the activities of our subcommittee. We chose the topic of the investigatives measures (such as inspections, search and seizure orders, and also wiretaps and its related procedural guarantees).
- The regulation no. 2017/1939 provides that those investigative measures may be applied by the EPPO's Office for the crimes that are punished by a maximum penalty of at least 4 (four) years of imprisonment, but their application may be subject to limitations in accordance with national law.
- In particular, for example, in the subject of wiretapping activities, each member state has its own specific regulation: in Spain wiretaps can be order only if the crime is punished with more or equal to 3 years of imprisonment; in France at least 3 years; and in Italy as all we know at least 5 years.
- Consequently, we could discuss about a serious problem of necessary harmonization among the disciplines of the different Member States, in order to guarantee the effectiveness if the EPPO's action.
- The concrete application of the investigative measures must be respectful of the principle of the proportionality, in order to avoid a violation to the fundamental rights of individuals during the preliminary investigations of EPPO' Offices.

### CIVIL LAWYER: FEDERICO IACOPO MAMOLI

- I, in quality of head of Steppo civil lawyers committee, participated in the European Lawyers Association (ELA) annual meeting 2023 in Bratislava – Slovakia.
- In such context several international lawyers coming from many European countries gathered to discuss topical legal subject matters.
- One of the main topics was the "fight of corruption and commercial fraud" in the East Europe countries belonging to UE (Slovakia, Czech Republic, Hungaria, Polonia, Bulgaria).
- Most of the speakers insisted on the fact that, in consideration of the increasing number of this kind of criminal offences, new tools of intervention should be put in action. Also the role of the European Public Prosecutor Office (EPPO) was mentioned and discussed by the attendees coming from almost all european states.
- I exploited that occasion to talk about our Steppo Programme. Most of the participants showed a huge interest in the innovative content of Steppo and announced the promotion of the benefits of EPPO in their countries and contribute to the Steppo 2024 edition.
- With this regard, ELA Board of Directors decided to invite me at next ELA Board Meeting that will take place in Luxembourg in November 2023 to discuss further options of collaboration between ELA and STEPPO programme.

### UPDATE ON RECENT ACTIVITIES OF THE EPPO

Carousel Fraud: the first big operation of the EPPO of Venice has been done with requests of seizures and of precautionary measures for people and estates and they have been ordered by the Judge of Preliminary investigations of Padua .

The measures have been executed simultaneously in Italy, Poland, Great Britain and other European countries which have subscribed the reinforced cooperation

The damage to the VAT is estimated in more than 26 Million Euros.

### UPDATING 15.06.2023

- The EDP of Rome has produced new «Sentenze» and «Ordinanze» of the Tribunale del Riesame of Palermo and Court of Cassation about a big Carousel Fraud in Palermo – The papers will be studied and an anlysis will follow and will be published in a blog;
- The carousel fraud is about preventive seizures which have been requested and executed by the European Public Prosecutor's Office in Palermo;
- The execution was ordered by the European Public Prosecutor's Office of Madrid according to Art, 31 and 32 of the EPPO regulation.
- We encourage people to sign up to this Committee.

#### WORKING ARRANGEMENTS WITH EU PARTNERS

- On I2 June, the EPPO signed a working arrangement on cooperation with the European Judicial Training Network (EJTN).
- Under this arrangement, both organisations have committed to work together to develop and implement long-term training periods at the EPPO for prosecutor, judges and court and prosecution staff, as well as study visits and residential and online training activities.
- The new cooperation between EJTN and EPPO also covers a structured exchange of information in view of facilitating the planning of training activities, the provision of legal English training, and the funding of judiciary learning grant visits to the EPPO.
- The negotiations on a similar WA with CEPOL have been finalised. The WA will be signed in autumn 2023 after approval by the CEPOL Management Board and adoption by the College of the EPPO.

# 5 May 2023, Italy: EPPO seizes €700 000 in investigation into fraud involving funds for organic farming

The European Public Prosecutor's Office (EPPO) in Palermo (Italy) has seized over €700 000 in assets against seven suspects and their companies, in an investigation into fraud involving national and EU agricultural funding aimed at supporting the conversion to organic farming.

The crimes under investigation are aggravated fraud for obtaining public funds, and false statements in a public deed. The suspects are believed to have presented false certifications concerning the requirements to be awarded the non-repayable funds – thus misleading the paying agency, which granted the sums now subject to the freezing order.

The total amount obtained by the suspects was €713 377.61, granted by the Calabrian Region under the partly EU-funded Rural Development Programme (RDP) 2014/2020. In order to recover the damages to the national and EU budgets, the Italian Financial Police, on behalf of the EPPO, has seized the bank accounts and real estate of the suspects under investigation.

# ■ 25 May 2023, Italy: EPPO seizes €20 million in investigation into Palermo's water service company

On behalf of the European Public Prosecutor's Office (EPPO), the Italian Financial Police (Guardia di Finanza) have executed a freezing order of up to  $\leq 20$  million, in an investigation involving the public company that operates the water service in Palermo (Italy).

The investigation began after the European Investment Bank (EIB) filed a complaint with the EPPO, regarding a loan agreement granted to the public company of the municipality of Palermo responsible for managing the drinking water distribution and the sewage system for the entire province.

In 2020, the public company received a loan of €20 million from the EIB, funded by the European Fund for Strategic Investments (EFSI) and guaranteed by the European Union. The loan agreement, signed on 20 December 2017, concerned an investment program for drinking water production and wastewater treatment.





#### Info

- BENEFICIAL OWNER: a beneficial owner is a natural person or persons who ultimately owns or controls an interest in a legal entity or arrangement, such as a company, a trust, or a foundation. It is particularly effective in a strategy to combat the phenomena of money laundering, to be able to bring directly to one or more natural persons the sphere of real interest in reference to the capital used and transiting in the territory of the European Union, so as to weigh its angularly strategic aspects, such as origin or ultimate purpose
- MISSING TRADE FRAUD: Missing trader fraud (also called missing trader intra-community fraud or MTIC fraud) involves the theft of <u>Value Added Tax</u> (VAT) from a government by fraudsters who exploit VAT rules, most commonly the <u>European Union VAT rules</u> which provide that the movement of goods between <u>member states</u> is VAT-free
