- The CoE will be active and financially supported starting from 2024 to 2026 (36 months).





# 4. LAWYERS' SUBCOMMITTEE

CHAIR: FABRIZIO DE' SANNA – FEDERICO IACOPO MAMOLI

#### CRIMINAL LAWYER: FABRIZIO DE' SANNA

- Before the Court of Justice was proposed the first reference for a preliminary ruling concerning the activity of the European Public Prosecutor's Office, and more precisely the management of investigative activities.
- During these meetings we have had the opportunity to discuss the problem of insufficient harmonization at EU level - in the field of evidence.
- Well, this problem has already had a first realization: in a cross-border investigation (involving Germany and Austria) the measure already validated (seizure) in the State in which the investigation was carried out, has been called into question in the State of execution.
- Consequently, the Vienna Court questioned the Union Court on the need for a review of all the substantive requirements of the investigation measure, also pointing out the risk that this might lead to a review of the judicial decision of another State.
- We await the Court's reply.

#### CIVIL LAWYER: FEDERICO IACOPO MAMOLI

- I, in quality of head of Steppo civil lawyers committee, participated in the Association of Young Lawyers General Annual Meeting (AGAM) that took place in Milan on 28 June 2023.
- A new "board of directors" of AGAM was elected in that context. Such board and the new chairman showed a huge interest in "Steppo" themes both the new civil law commission of AGAM and the criminal law commission of it by proposing me to cooperate with them in the next future.
- They asked me to make an update on the new developments of Steppo. I explained to them the significant progress and success of Steppo that has just been awarded as "Center of excellence" by the European Union.
- We agreed that I'll report to them more in details in September in consideration of the next decisions taken by our Steering Committee.

#### CIVIL LAWYER: FEDERICO IACOPO MAMOLI

- I also attended the four days seminar "Talk to the future" organized by Milan Bar Association (Ordine Avvocati di Milano). In such venue several lawyers and professionals gathered to discuss topical legal subject matters and one of the main topics was the "fight of corruption and commercial fraud".
- Most of the speakers insisted on the fact that, in consideration of the increasing number of this kind of criminal offences, new tools of intervention should be put in action. Also, the role of the European Public Prosecutor Office (EPPO) was mentioned and partly discussed by the attendees.
- I had a brief talk to some members of the Ordine Avvocati di Milano board starting to explore the most proper avenues to promote Steppo in the next future. They promised me to better collaborate in that respect from September onwards.

#### UPDATE ON RECENT ACTIVITIES OF THE EPPO

Carousel Fraud: the first big operation of the EPPO of Venice has been done with requests of seizures and of precautionary measures for people and estates and they have been ordered by the Judge of Preliminary investigations of Padua.

The measures have been executed simultaneously in Italy, Poland, Great Britain and other European countries which have subscribed the reinforced cooperation

The damage to the VAT is estimated in more than 26 Million Euros.

#### **UPDATE: SUMMER 2023**

- The EDP of Rome has produced new «Sentenze» and «Ordinanze» of the Tribunale del Riesame of Palermo and Court of Cassation about a big Carousel Fraud in Palermo The papers will be studied and an analysis will follow and will be published in a blog;
- The carousel fraud is about preventive seizures which have been requested and executed by the European Public Prosecutor's Office in Palermo;
- The execution was ordered by the European Public Prosecutor's Office of Madrid according to Art, 31 and 32 of the EPPO regulation.

#### UPDATES ON ACADEMIC PAPERS

Paul Le Fèvre has recently published "THE EUROPEAN PUBLIC PROSECUTOR AT A CROSSROADS - Chronicle of the European Public Prosecutor No. 2"

The article provides an overview of the EPPO's activities in 2022, some data on the investigations carried out, the first convictions obtained, and some final thoughts on the risk of forum shopping in the cross-border investigations.

In 2022:

3318 reports (1,924 from individuals, 1,361 from public institutions or bodies)

865 investigations

20 convictions

Major investigation:

"Operation Amiral" 2.2 billion VAT fraud, almost all Member States involved, 9000 legal persons and 600 natural persons investigated

#### UPDATES ON ACADEMIC PAPERS

Benedetta Minucci has recently published on Eurojus (issue No 3, 2023) a new paper entitled «La Procura europea e l'effettività della cooperazione giudiziaria in materia penale: tutele disomogenee e reali progressi»

The contribution aims to examine the critical issues highlighted by the establishment of the European Public Prosecutor, in order to assess how and to what extent the EPPO has contributed to ensuring effectiveness in the judicial cooperation in criminal matters. The papers also deals with the preliminary ruling made by the Vienna Court of Appeal and pending before the Court of Justice (C-281/22), concerning the EPPO's Founding Regulation, on which the Advocate general already delivered an opinion on June 22<sup>nd</sup>.

#### UPDATES ON CASE LAW

- Preliminary ruling question referred to the CJEU by the Oberlandesgericht Wien, Case C-281/22 G.K., G. K. e a. (Parquet européen)
  - The question concerns the nature of the review which the judicial authorities of the Member State of the Assistant European Public Prosecutor may carry out of the lawfulness of the investigative measures requested on their territory by the European Public Prosecutor Delegate in charge of the investigation. **Formal** or **substantive**?
- OPINION OF ADVOCATE GENERAL ĆAPETA, delivered on 22 June 2023:
  - In the case of cross-border investigations, the court approving a measure to be carried out in the Member State of the assisting European Delegated Prosecutor may assess only the aspects related to the execution of an investigative measure
  - In the case of cross-border investigations, the court in the Member State of the assisting European Delegated Prosecutor must accept the assessment by the handling European Delegated Prosecutor that the measure is justified, whether or not the latter is approved by prior judicial authorisation of the court in the Member State of the handling European Delegated Prosecutor





## **UPDATES - JULY 2023**

#### ■ 4 July 2023, Italy: €3 million seized in real estate and current accounts within an EPPO fraud investigation

In an investigation led by the European Public Prosecutor's Office (EPPO) in Turin, 13 properties, 4 plots of land and €400 000 of money in current accounts were seized in several cities in Italy by the Italian Financial Police (Guardia di Finanza) from Asti. Four suspects are believed to have fraudulently obtained around €3 million in EU and national funds to present their machines for food packaging at trade fairs abroad.

Between 2017 and 2020, three board members and the manager of the company supposedly provided false information (e.g. alteration of financial statements) to the officials responsible for disbursing loans and received credits for over € 2.8 million from the EU program for the Competitiveness of Enterprises and Small and Medium-sized enterprises (COSME) and almost € 70 000 from national funds.

The investigation by the Guardia di Finanza revealed that the actual financial situation of the company involved in the fraud was critical and that they had suffered an operational loss of €11.9 million and a negative net worth of €7.3 million at the end of 2019.

The four suspects were reported to the EPPO office in Turin in February 2022 for aggravated fraud against the European Union, undue receipt of public funds and fraudulent bankruptcy. The criminal proceedings are still at the preliminary investigation stage, and the responsibility of the suspects will be finally established in the event of a conviction.

## **UPDATES - JULY 2023**

■ 5 July 2023, Italy: EPPO seizes €570 000 in investigation into fraud involving dairy products for schools

On the radar of the EPPO is a company based in Puglia, acting on behalf of a temporary association of companies that won a procurement procedure to supply dairy products to schools – a EU scheme to help children develop healthy eating habits, financed by the European Agricultural Guarantee Fund (EAGF). For that purpose, the company signed a contract with the Italian Ministry of Agriculture, Food and Forestry Policy (MIPAAF).

On 2019, the legal representative of the company submitted to the Italian agricultural payments agency AGEA (Agenzia per le erogazioni in agricoltura) and MIPAAF a payment request of €570 000, for the expenses incurred for the provision and distribution of food.

However, following controls by AGEA, several elements brought into question the reliability of the documents submitted by the company. According to the investigation, the company submitted fraudulent bank statements and falsified account books to certify that it had paid the suppliers. While the food was supplied, the evidence shows that the company did not actually pay any of the invoices from its suppliers, and was therefore not entitled to reimbursement.

In order to recover the damage to the EU budget, the pre-trial Judge of the Court of Bari issued a freezing order of €570 000, which was executed in full, by freezing the bank account of the company.





