- As anticipated during the last meeting, the first reference to the Court of Justice was proposed on EPPO matters and, specifically, on the subject of transnational investigations.
- In particular, the Court of the European Union was asked to rule on the actual need for a review of all the **substantive** requirements of the investigative measure already ordered by the Court of another Member State.
- Pending the Court's ruling, we wrote an article, entitled "Art. 31 of Reg. EU 2017/1939 First reference for a preliminary ruling on cooperation: form or substance?" which summarizes the issue and possible scenarios.
- We will keep you informed about the Court's reply.

CIVIL LAWYER: FEDERICO IACOPO MAMOLI

- I, in quality of head of Steppo civil lawyers committee, conducted a wide networking activity over the period 20 July 12 September 2023.
- I had the opportunity to visit some colleagues of Stockholm and Copenhagen Bar of lawyers during my trip in Sweden and Denmark and talk about Steppo. I explained to them the significant progress and success of Steppo that has just been awarded as "Center of excellence" by the European Union.
- With regards to Sweden, even if it decided not to join the EPPO, the swedish lawyers of Stockholm Bar Board of Directors told me that the swedish government has just started reconsidering the option of joining EPPO at a later stage. As for Denmark, the head of international cooperation office of Copenhagen Bar, insisted on the fact that Denmark has been exploiting a clause of permanent exemption from the provisions set by European Union regarding criminal law but they will cooperate more in the future.
- I also managed to contact some italian important lawyers that could be interested in participating in Steppo edition 2024. They promised me that they will promote it in their law firms.
- In addition to this, I kept being in constant touch with my contacts in ELA (European Lawyers Association) to organize my next visit in Luxembourg in November 2023 in order to match their request of updating the Association about the progress of STEPPO and discuss the possibilities of mutual cooperation.


OTHER NEWS

10 October 2022, Romania: businessman and company indicted for fraud and money laundering

- A Romanian businessman and his company are facing indictment at the Bucharest Tribunal for fraudulently obtaining over €3 million in EU funds for the development of a medical research center called RECUMED. The European Public Prosecutor's Office (EPPO) in Bucharest is leading the investigation, suspecting not only fraud but also money laundering following the receipt of the funds.
- The investigation reveals that the suspects submitted false documents and statements to secure the EU grants, including fictitious competing offers and misleading information about the Spanish company's technical capacity. After obtaining the funds, the Romanian company transferred the money through various entities in Spain, Cyprus, and Portugal, ultimately channeling it back to Romania through bogus invoices.
- This case highlights the crucial role of the EPPO in combating EU fraud and emphasizes the importance of financial laws in tracking funds through complex money laundering schemes. Effective cooperation and strict oversight are essential in the fight against financial crime at the European level to safeguard EU funds and hold those responsible accountable.





