

### 5 October 2023, Italy: EPPO seizes assets in investigation into farmer with mafia ties.



Assets of a farmer with suspected ties to organized crime were seized in Italy for alleged agricultural funding fraud, where the suspect fraudulently obtained €245,000 from the European Union.

EPPO played a crucial role in this operation by ordering the seizure, highlighting its significance in combating transnational financial crimes.

The involvement of the banking system, as evidenced by the seizure of bank accounts, underscores the importance of financial institutions in facilitating and uncovering such fraudulent activities.

### 30 October 2023, Italy: Over €53 million seized in EPPO investigation into vast VAT fraud scheme



The European Public Prosecutor's Office in Milan is leading an investigation into a €53 million VAT fraud scheme, resulting in one arrest and more than 10 individuals under scrutiny.

The case centers around a VoIP technologybased fraud spanning several countries.

EPPO's role is pivotal in addressing crossborder financial crimes, and the involvement of the banking system is crucial for detecting and preventing fraudulent activities.





# **GENERAL** RECENT DEVELOPMENTS IN COOPERATION WITH NON-PARTICIPATING MEMBER STATES UPDATE

As of 1 November 2023, Ireland started to cooperate on mutual legal assistance and asset recovery with the EPPO.

• Since Ireland is still not (yet) able to recognise the EPPO as a competent authority in application of the existing EU instruments, such as the 2000 MLA Convention or the Freezing Orders Framework Decision\*, the cooperation is based on the unilateral recognition under the Irish MLA Act (2008), as recently amended to this purpose

\* Ireland is not bound by the EIO Directive 2014/41/EU and the Freezing and **Confiscation Regulation** 2018/1805.

### WORKING ARRANGEMENTS WITH NON-EU PARTNERS

 On 21 November, the EPPO will conclude a working arrangement on cooperation with the Prosecution Office of Bosnia and Herzegovina.

> This WA, similarly with the other arrangements concluded with national authorities of other States Parties to the Council of Europe (CoE)1959 Convention and its Additional Protocols, will recognise the EPPO as a competent judicial authority for these CoE instruments

EPPO participates as an observer in the activities of the CoE's Committee of experts on the operation of European Conventions on Co-operation in Criminal Matters (PC-OC).

### EPPO'S PARTICIPATION IN THE PC-OC

At the 84<sup>th</sup> plenary meeting of PC-OC, Strasbourg, 14-16 November 2023, the PC-OC members approved the conclusion of the feasibility study carried out, that "a self-standing agreement to regulate cooperation between the EPPO and non-EU Member States under the Convention (of the Council of Europe – our note) is not feasible at this stage, given that support from the EU would be indispensable for such an endeavour. The PC-OC considers that this question could be reexamined if there is a change in the position of the EU Member States in the future.".

> The EPPO took note of this conclusion and recalled that a majority of States Parties to the CoE 1959 Convention accepted to cooperate with the EPPO on the basis of this instrument.

# Eppo and Spain: some cases of fraud and simulation in the CAP subsidies v

The new CAP 2023 to 2027 moves from being a policy based on the description of requirements to be met by the final beneficiaries of support to being a policy geared to achieving concrete results, linked to three general objectives:

"(a) to promote a smart, competitive, resilient and diversified agricultural sector that ensures long-term food security;

(b) to support and strengthen environmental protection, including biodiversity, and climate action and contribute to achieving the Union's environmental and climate objectives, including commitments under the Paris Agreement;

(c) strengthening the socio-economic fabric of rural areas".

These general objectives are further broken down into nine specific objectives, based on the three pillars of sustainability and complemented by a common crosscutting objective to modernise the agricultural sector through knowledge, innovation and digitisation in rural areas. (web Agricultural Ministry)

The CAP is a highly efficient investment from the EU's budget, it means of the EU budget 33,2%. Spain has taken advantage from the CAP resources to consolidate a key sector for the country economy. (web Agricultural Ministry)

control of this The budget has detected in Spain in September 2023 a criminal network, as reported in the press, of a of fraud agricultural subsidies of the CAP worth 3 million euros in Cordoba, Seville, Ecija and Jerez de la Frontera. They made false contracts of transfer of use of plots of land to persons while the owners of these lands were unaware of the fraudulent use to obtain these subsidies. The criminals created a complex criminal network involving several companies.



Now, in November 2023 several people in the region of Castilla y Leon are now under investigation for fraud of EU subsidies, subsidies linked to animal health and welfare. These people are allegedly falsifying the conditions necessary to obtain these CAP subsidies to the value of one million euros. The farmers investigated were applying for aid from the pack by pretending to graze in different areas.

# GENERAL UPDATE

Signing of a Working Agreement on Training with the European Public **Prosecutor's Office (EPPO)** 

September 26, 2023, the On at headquarters of the Economic-Financial Police School in Ostia, the General Commander of the Guardia di Finanza, Gen. C.A. Andrea De Gennaro, and the European Public Prosecutor, Laura Codruta Kövesi, signed a Working Agreement to develop, at the Economic-Financial Police School in Ostia, training activities under the aegis of the EPPO Academy project.

Over €53 million seized in EPPO investigation into vast VAT fraud scheme

The European Public Prosecutor's Office (EPPO) in Milan (Italy) is leading an investigation into a vast VAT fraud scheme, with estimated damage of at least €53 million. One person has been arrested and more than 10 are under investigation, with several searches executed in Italy (Milan, Novara, Genoa, Rome and Palermo) and in Switzerland.

According to the evidence, the scheme is in the area of VoIP (Voice over Intranet Protocol) – a technology that allows users to make voice calls via the intranet involving companies in Czechia, Germany, Italy, Romania, Switzerland and the UK. The main beneficiary is understood to be a large company in Italy's Emilia-Romagna region, with a core business of trading in the gas sector.

The estimated damage, at this point in the investigation, is €53 898 816.69, and this has been fully seized from the account of the large company alleged to be the main beneficiary. Seizures have also been made, during the searches, of cash and luxury watches.


The investigation was opened following a report by the Italian Revenue Agency (Agenzia delle Entrate), and carried out by the Guardia di Finanza (the Italian **Financial Police).** 

The Annual Report for the activities of the **European Public Prosecutor's Office (EPPO)** in 2022 shows a clear focus on EU fraud affecting public revenue, in particular crossborder VAT fraud. By the end of 2022, the **EPPO had 1117 active investigations with** overall estimated damages of €14.1 billion, nearly half of which (47%) resulted from VAT fraud.


