Active cooperation with national authorities is vital for EPPO to effectively fight crimes damaging the Union's interests.



 We are pleased to inform you that the Court of Justice of the European Union has issued the judgment on the 21st of December 2023, in the matter of the first preliminary ruling concerning the functioning of the European Public Prosecutor's Office (C281/22).

$\circ~$ The Court has established the following principle:

Articles 31 and 32 of Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('the EPPO') must be interpreted as meaning that the review conducted in the Member State of the assisting European Delegated Prosecutor, where an assigned investigation measure requires judicial authorisation in accordance with the law of that Member State, **may relate only to matters concerning the enforcement of that measure, to the exclusion of matters concerning the justification and adoption of that measure**; the latter matters must be subject to prior judicial review in the Member State of the handling European Delegated Prosecutor in the event of serious interference with the rights of the person concerned guaranteed by the Charter of Fundamental Rights of the European Union.

- I, in quality of head of STEPPO civil lawyers committee, kept conducting a wide networking activity over the period 15 December 2023 – 16 January 2024.
- I started to promote STEPPO 2024 programme as follows: I participated in AGAM ("Association of Milan Young Lawyers") Christmas party and I illustrated the content of Steppo to most of lawyers who were present at the party.
- Some of them were attendees of STEPPO 2023 edition and, in consequence of their positive assessment of the quality of their experience, they suggested other lawyers next to them at the party and outside that environment, to join the programme 2024.
- I kept contacting several lawyers from prominent italian law firms that showed a huge interest in the programme.
 I will have meeting with some of them on Friday 19 January and Monday 22 January.
- The good point is that from the time I provided them with STEPPO website, they told me they consult it frequently and devote some professionals to check the news on it and then report to the law firm partners.
- I'll receive the response of entities from the south of Italy soon about their potential involvement in STEPPO and the setting of new "best practices" in the area of prevention.



These are the latest judgements on fraud against the EU funds that we have recently added on our website.

Corte dei conti Sicilia n. 3/A/2024

In judgment 3/A/2024, the Court of auditors has confirmed the first-degree conviction of an individual to pay € 15,000.00 to the Regional Department of Agriculture, Rural Development, and Fisheries as a reimbursement for wrongfully receiving a non-repayable contribution from the European Fisheries Fund (EFF) 2007-2013. This was done by submitting false declarations regarding the requirements specified in the call for applications.

Corte dei conti Campania n. 11/2024

The Court of Auditors in its judgment 11/2024, sentenced the fisherman to pay the sum of EUR 40,000 as compensation for pecuniary damage. It is a question of undue receipt of the European Fisheries Fund (EFF 2007-2013, 'aid for socio-economic compensation' measure, Regulation 1198/2006/EC, Article 27(c)), paid to the fisherman by Regione Campania, for failing to convert his professional activity to other regimes than sea fishing, thus rendering the intended purpose of the EFF null and void.

The judgment in case C-281/22

On 21 December 2023, the CJEU delivered the judgment in the first referral for preliminary ruling concerning the interpretation of the EPPO Regulation (Case C-281/22). The ruling is in line with the EPPO's position expressed in the College Guidelines on Article 31 and in the submissions of the EPPO before the CJEU.

The judgment in case C-281/22

"Articles 31 and 32 of Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('the EPPO') must be interpreted as meaning that the review conducted in the Member State of the assisting European Delegated Prosecutor, where an assigned investigation measure requires judicial authorisation in accordance with the law of that Member State, may relate only to matters concerning the enforcement of that measure, to the exclusion of matters concerning the justification and adoption of that measure; the latter matters must be subject to prior judicial review in the Member State of the handling European Delegated Prosecutor in the event of serious interference with the rights of the person concerned guaranteed by the Charter of Fundamental Rights of the European Union."

On 15 December 2023, the General Court of the EU issued its Order in Case T-103/23.

ORDER OF THE GENERAL COURT IN Case t-103/23

Admitting the exception of inadmissibility lodged by the EPPO, the Court dismissed the action for annulment of a decision of a permanent chamber of the EPPO of bringing a case to judgment and partially dismissal of that case.

GENERAL UPDATE

Over €53 million seized in EPPO investigation into vast VAT fraud scheme

The European Public Prosecutor's Office (EPPO) in Milan (Italy) is leading an investigation into a vast VAT fraud scheme, with estimated damage of at least €53 million. One person has been arrested and more than 10 are under investigation, with several searches executed in Italy (Milan, Novara, Genoa, Rome and Palermo) and in Switzerland.

According to the evidence, the scheme is in the area of VoIP (Voice over Intranet Protocol) – a technology that allows users to make voice calls via the intranet – involving companies in Czechia, Germany, Italy, Romania, Switzerland and the UK. The main beneficiary is understood to be a large company in Italy's Emilia-Romagna region, with a core business of trading in the gas sector.

The estimated damage, at this point in the investigation, is €53 898 816.69, and this has been fully seized from the account of the large company alleged to be the main beneficiary. Seizures have also been made, during the searches, of cash and luxury watches.

The investigation was opened following a report by the Italian Revenue Agency (Agenzia delle Entrate), and carried out by the Guardia di Finanza (the Italian Financial Police). The Annual Report for the activities of the European Public Prosecutor's Office (EPPO) in 2022 shows a clear focus on EU fraud affecting public revenue, in particular cross-border VAT fraud. By the end of 2022, the EPPO had 1117 active investigations with overall estimated damages of ≤ 14.1 billion, nearly half of which (47%) resulted from VAT fraud.



- There will be a future fourth blog post (February) on the publication of the Oxford Commentary to the 1970 UNESCO and 1995 UNIDROIT Conventions on Stolen or Illegally Transferred Cultural Property, to which all the Subcommittee chairs have contributed.

It also addresses the issue of criminalising and prosecuting offences against cultural heritage related to illicit trafficking. The analysis of practice in this area can be an important source of knowledge and guidance for EU authorities, particularly EPPO, and Member State and their judicial bodies.

- Andrzej Jakubowski, one of the Committee chairs, will join the EPPONFI – EPPO team at the University of Milan-Bicocca in April 2024.

- The Subcommittee will held a teaching session in April: 'The EPPO's role in combatting trafficking in cultural goods for 2022-25' – it will address the EU action plan against trafficking in cultural goods for 2022-25 in the context of contemporary threats of armed conflict and terrorism. It will discuss the legal and institutional framework of this plan, with particular emphasis on the effective prosecution of perpetrators.

Other key activities:

- Capacity building via membership recruitment
- Tracking progress on the implementation of the EU Action Plan against trafficking in cultural goods for 2022-25

- Awareness raising (through networking, developing more blogs and integrating the Committee's aims into existing discussions elsewhere (conferences etc.))
