


## **NEXT ACTIVITIES:**

- This will increase the number of countries part of EPPO to a total of 24.




- Nowadays Hungary is the only country that is not a member of EPPO.


On Facebook specifically, the introduction and application of the new guidelines for posts have proven to be highly effective, resulting in a remarkable 120% increase in user interest.

# GENERAL UPDATE

The EPPO investigation, code-named Moby Dick, uncovered a millionaire **VAT fraud** in the electronic goods sector.

An **unprecedented** carousel fraud took place between 2020 and 2023 with fake invoices worth 1.3 billion euros.

Mafia clans are also involved in fraud.



The investigation was conducted by Guardia di Finanza of Varese and the Italian State Police (Squadra Mobile di Palermo and Servizio Centrale Operativo), under the supervision of the EPPO.

Investigations are currently ongoing in several EU countries and hundreds of police forces have been involved.



### EPPO POLICY ON STUDY VISITS

### The Acting Administrative Director,

Having regard to the Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('EPPO')' (hereinafter referred to as 'the EPPO Regulation'), and in particular Article 19 thereof;

Having regard to Decision 025/2024 of the College of the EPPO of 24 April 2024 for the temporary occupation of the management post of Administrative Director of the EPPO, Whereas

- (s) For administrative and budgetary purposes, the EPPO shall be managed by its Administrative Director.
- (2) In order to ensure that practice remains transparent and consistent, the rules on the deployment of study visits should be laid down in an Administrative Director Decision. (3) The EPPO may benefit from initiatives allowing constant interaction with its environment and with mmunities of interest for knowledge sharing, by enriching its expertise and prosecutorial acumen.
- As well, it might heighten its outreach within the prosecutorial sphere by permitting external parties interested in its mandate to directly observe and experience the duties embedded within its operations Has adopted the following decision

# MEETING WITH PRESIDENT OF MILAN'S LAWYERS ORDER

On Thursday 19/11/2024 Avv. Federico Mamoli helded a meeting with the President of Milan's Lawyers Order Avv. Antonino La Lumia. This meeting made stronger the collaboration between the Lawyers Order and Steppo's activities. Avv. Federico Mamoli proceeded to inform various legal studies in Milan and other colleagues about the aforementioned meeting.



# SENT. N. 330877-2024, sezione V, Cassazione penale

- It appears of interest for our matter to recall the recent ruling of the Court of Cassation regarding Eppo jurisdiction in the event of evidentiary seizure obtained by the competent PED (sentence no. 33087 of 2024, section V of the Criminal Court of Cassation).
- The fact originates from an episode that occurred nearby Salerno: the suspect was in fact reached by an evidentiary seizure issued by the PED of Naples in relation to smuggling, forgery and evasion of customs duties. The suspect proposed a review to the Court of Freedom of Naples and the latter annulled the seizure decree, returning the assets subject to restrictions as a result of the measure adopted.
- As far as we are concerned, I would like to point out that the PED of Naples appealed to the Court of Cassation, arguing that the Court of Naples had acted in violation of the rules on territorial jurisdiction.

# SENT. N. 330877-2024, sezione v cassazione penale

In the opinion of the European Prosecutor, in fact, the ordinary legislation referred to in the articles should have been applied. 8 et seq. c.p.p.; in the present case - states the PED - the jurisdiction was rooted in the territory of Salerno and not Naples. Furthermore, the appellant continues, the European Public Prosecutor's Office is also based at the Court of Salerno.

As we know, the Supreme Court rejected the appeal, confirming the return of the assets to the suspect.


The Court of Cassation has in fact maintained that the functionally competent authority regarding the evidentiary seizure decree issued by the PED is the Review Court of the capital of the province in which the PED office is located, since the special legislation relating to the EPPO functions, in the wake of in any case the ordinary rules on the territorial jurisdiction of the national judge.



I proventi venivano riciclati anche tramite il crimine organizzato russo. L'operazione ha portato a 32 arresti e al sequestro di beni per oltre 47 milioni di euro.

L'indagine "Moby Dick", coordinata dall'EPPO di Milano e Palermo, ha smascherato una frode IVA da 520 milioni di euro legata a gruppi mafiosi. L'operazione, che ha coinvolto 43 arresti e 160 perquisizioni in oltre 10 paesi, ha portato al sequestro di beni per milioni di euro, tra cui 192 immobili e 44 veicoli di lusso. Tra il 2020 e il 2023, l'associazione criminale ha emesso fatture per 1,3 miliardi di euro su beni elettronici, usando metodi mafiosi per risolvere conflitti interni. **Complessivamente, sono indagate 195 persone e coinvolte** oltre 400 aziende.



### IL CASO

- L'interessante provvedimento del GUP di Mllano (giudice per le udienze preliminari) in un caso di evasione di IVA transfrontaliera, quindi, le cd FRODI CAROSELLO. L'indagine ha coinvolto più giurisdizioni nazionali competenza che ha EPPO. In particolare la difesa delle parti ha sollevato dubbi in merito sulla competenza di EPPO, contestando l'assenza di un'istanza a procedere da parte del Ministero della Giustizia italiano facendo riferimento all'art.9 del codice penale italiano.
- La giurisprudenza di merito ha stabilito la risoluzione del conflitto di competenza è sollevabile SOLO dalla procura nazionale, quindi non da altre parti giurisdizionali.
- Non si applica l'art 9 del codice penale italiano come sostenuto dalla difesa.
- La sentenza conferma una giurisprudenza consolidata ricordando di fatto le decisioni del Tribunale di Catania e Palermo


